Grants and Awards In 2016, through its grants to the AANI's Clinical Research Training Scholarship Program, the ABF enabled the AANI to identify and further the research of 20 of the best and the brightest early career clinical neuroscientists working on innovative research to treat, prevent or cure a wide variety of diseases of the brain and nervous system. In addition, ABF funded scientific awards for ALS and Alzheimer's research and gave leadership awards to member of the public engaged in fundraising and raising awareness of efforts to cure brain disease.

Public Education The American Brain Foundation (ABF) participated in the Brain Health Fair held at the 2016 American Academy of Neurology's Annual Meeting in Vancouver, British Columbia, Canada. This free, daylong family event connected nearly 3,000 patients, families, and caregivers affected by a neurologic disorder with important resources to win the battle against brain disease. People attended free classes to learn from some of the best and brightest neurologists in the world about the latest research advances in Alzheimer's, autism, brain injury, epilepsy, headache, multiple sclerosis, Parkinson's, sleep disorders, stroke, and other types of brain disease. The Exhibit Hall offered fun activities for kids and teens, and giveaways. ABF created a media campaign and special event to raise awareness of brain disease through personal stories.


